### Elder Abuse: Identifying and Assisting the Victim

Elder abuse is a growing problem. The National Center on Elder Abuse (NCEA) defines elder abuse as "intentional or neglectful acts by a caregiver or 'trusted' individual that lead to, or may lead to, harm of a vulnerable elder. In many states, younger adults with disabilities may qualify for the same services and protections.

### Elder Abuse - Tennessee

Elder abuse includes: physical, sexual, and emotional abuse, caretaker neglect, financial exploitation and self-neglect. Elder Protective Services can only investigate cases of abuse where the person is age 60 and over and lives in the community.

### Reporting Elder Abuse & Neglect | Mass.gov

Limited past research means limited data to guide practitioners, policymakers, and trainers. What we do know now is alarming: elders who experience a form of abuse, even modest abuse, have a reported 300% higher risk of death. Even verbal abuse has been linked to seniors' physical health issues and well-being.
